Re: PC-23-0049: The matter of Scott Jewers and an Unknown Officer

This will acknowledge receipt of the above complaint, a copy of which is attached for your information and attention together with two subsequent emails from Mr. Jewers. The Form 5 was received on March 15, 2023, but the complaint was not accepted for processing until March 23, 2023, when the attached emails from Mr. Jewers were received.

The complaint is to be investigated only in relation to the officer who removed handcuffs from Mr. Jewers at HRP headquarters on August 2, 2022.

In accordance with Sections 36(1) and 42(3) of the *Police Act* Regulations, a copy of a Notice of Completion of Investigation in Form 9 shall be forwarded to the complainant, the member complained of and to me, on or before **May 22, 2023.**

Should it become apparent during the course of the investigation that there will not be sufficient time to complete it, a request in writing must be made to me to extend the timeline. I will require detailed reasons for the request.

In the event of a Withdrawal of Complaint (Form 6) or an Informal Resolution of Complaint (Form 7), a copy of either form shall be forwarded to the complainant, the member complained of and to me, therefore making the submission of a Form 9 unnecessary.

Who can make a complaint?

The conduct of Halifax Regional Police employees is guided by the Code of Ethics.

Anyone who feels they haven't been treated properly or who has concerns about the actions of a Halifax Regional Police officer, or the policies or service provided by Halifax Regional Police, may file a complaint.

You can make a complaint against any Halifax Regional Police officer, including the Chief of Police.

Do I have to contact Professional Standards to make a complaint?

No. You may make your complaint to any of the following:

any member of the Halifax Regional Police

the Halifax Regional Municipality Board of Police Commissioners

the Police Complaints Commissioner

You can discuss your concern with any of the above but if you want to make a formal complaint, you must fill out and complete the Form 5 - Public Complaint – [Section 31(1)] Police Act Regulations form [PDF].

The Police Complaints Commissioner receives a copy of every formal complaint, regardless of where it is filed.

NSHA, upon clearly knowing there was a massive conflict of interest, lied and tried to cover up the incredible failing of the staff. Including NSHA giving my Bookbag to two non-associated HRP Officers who, as it was reported, went through all my stuff including my wallet... The next day, the person whom they used to claim was me, came to me about my bookbag, and told me what the police did and asked "Do you want to rock paper scissors for one of the \$20's".... I had 2, \$20 bills in there... they 100%, were given my stuff. NSHA has also lied about this breach. The psychologist was recorded...and her behavior is shocking... It's the definition of Criminal Negligence. I heard the two officers who arrested me talking, they knew something was wrong, and it wasn't me. I was calm ,cool and collected the entire time. Officer 1, 2, 3 and 4. Didn't really mistreat me aside from Arresting me... Officer 5 who took my Cuffs Off - Should be fired and reprimanded immediately. The Supervisor should be fired - that was a criminal assault. Dan Kinsella knew about this but let his Officers take the heat to cover up for himself... hoping he could hold it over their heads.... And makes me wonder then about the Historic and Unprecedented Vote of Confidence that occured just 1.5 Months later, where 96% voted against the chief... It's an interesting coincidence

to say the least. While if any party thought i was a risk, why let me walk down to HRP? Because no party thought I was at risk. Including CSIS and RCMP.

The basic question here - WHY DIDN'T HRP LET ME FILE A COMPLAINT!? Because they knew they were in the wrong. This was Criminal Negligence at best.

As for torture, it was criminal assault. Because NSHA lied and knew they would have to file a complaint against HRP. They covered it up...and then forced me to Take risperidone under threat of severe violence. Which has a 46% chance of Erectile Dysfunction.... On top of other serious side effects. This was absolutely coercive torture. And HRP exploited, extorted, lied, cheat and stole as to specifically have me tortured and defamed... they knew it would affect my personal Record. And now the RCMP is saying that Because NSHA said I was retarded, they don't have to open a case... They are refusing to allow me to file a complaint regarding the core issue because HRP lied, and NSHA had to cover it up... So now RCMP is claiming because HRP and NSHA said im retarded . I don't get my chartered rights. I have no rights to open a case with the RCMP. While under Canadian law, Even if I was retarded.... I still have rights. Which means this is a Hate Crime... and HRP is well aware of the Damage their Actions caused. And is absolutely complicit in the matter... serving as their Message of Terror. Not only to me, but to the Entire Halifax Community. And I want this investigated as a Hate Crime.

While:

Department of Justice - What You Need to Know About Making a Citizen's Arrest - I asked valid, legal questions. Never made a threat, never loitered or caused any issues with Officers. As stated and requested, I discussed the issue with Law Enforcement for clarification as the evidence was incredible. Especially regarding My Wallet which just HAPPENED to end up in HRP Custody under JIM PERRIN. So in terms of my property, there being no limiting timeline and the fact these parties are ACTIVELY benefiting, as if this became public they would face consequences... Meaning they would be actively benefiting from the theft of my property. I asked for this to be clarified. Never, ever, ever said I was ever going to touch anyone, and have never made a threat. This was confirmed by RCMP and CSIS. Never made a threat, or have ever suggested violence. An arrest does not mean there is any physical contact.

HRP Basically committed several Hate Crimes. In addition to a False Arrest, Breach of trust, Slander, Defamation, Criminal Negligence and Criminal Assault. Just as a starter.
